NEA Retired Annual Meeting and NEA Convention

The 2024 NEA Retired Annual Meeting (RAM) was held June 30-July 1 in Philadelphia. This very interesting gathering takes place each summer in the days leading up to the NEA Representative Assembly (RA).

A Tale of Two Cities comes to mind, but this was a tale of two conventions. The NEA Retired Annual Meeting was quite normal. All of our official business, including the elections and new business items, was handled successfully.



Eddie Fifer, Dot Walton, Vashti Mallory, Lola McDowell, and Barbara Wilson representing VEA-Retired at the RAM in Philadelphia were pictured with Princess Moss, NEA VP, and Sandra Hatley of North Carolina, who made the winning bid on our auction item.

However, the NEA Representative Assembly was a different story. When the Virginia delegates met prior to the first session of the convention, we learned that negotiations with the NEA staff were not going well, and that a strike was possible. The first day of the convention seemed to be going well until President Fedderman had the entire Virginia delegation follow him off the floor to a private room. He prepared us for a possible strike the next day.

We were instructed to take everything with us when we left the convention that day. At the end of the first session, NEA President Becky Pringle made an announcement that confirmed what President Fedderman told us, that a strike was possible. The next morning, the Virginia delegates met as usual. but as we were en route to the convention, we were told the strike had started. The buses turned around and went back to the hotel.

For the remainder of our time in Philadelphia, the Virginia delegates met to give our collective opinion on each of the 100+ new business items. This information was to be sent to the NEA executive committee for deliberation. We also learned that voting for amendments and officer elections would be conducted via mail.

One might say that the RAM and NEA RA were the best of times and the worst of times, but the work of the Union didn't stop, and we accomplished what we went there to do.

Nominations Open for Distinguished Service Award

VEA-Retired is now seeking nominations for the 2025 Martha Wood Distinguished Service Award. Named in honor of its first recipient, this annual award is meant to recognize retired members who have made significant contributions to the growth of the active and retired Association, promotion of public education, and the welfare of public educators since retirement.

Nominees must have been members of NEA/VEA-Retired for at least five consecutive years as of January 15th of the award year and cannot hold a position on the VEA-Retired Council at the time of nomination. The VEA-Retired Council met in Richmond in March and, in addition to regular business, we were addressed by all six candidates seeking election to statewide VEA office. The council listened and endorsed. All three candidates it endorsed went on to win their respective seats at the VEA convention. To further illuminate retired presence at meetings, the council authorized the purchase of seat covers boldly printed with *VEA-RETIRED*. These were placed on the chairs assigned to the retired delegation at the 2024 VEA convention in Hampton. Participants could not miss the 17 retired delegates, always in their seats, focused and engaged. Whether it was new business or old, retired delegates had and shared opinions. Toward the close of business April 13, Lola McDowell presented outgoing VEA President James Fedderman with a gift from VEA-Retired in gratitude for his support over the past four years, and Dennis Pfennig presented the same to retiring VEA Executive Director Brenda Pike in recognition of her five years of service.

One of the goals of the Hampton gathering was to raise money for political action, specifically the VEA Fund for Children and Public Education. President Fedderman announced to the 422 convention delegates that as of the final day of convention, retirees had contributed \$16,891 to the VEA Fund, \$4,787 of that being contributed by the 17 retired delegates (pictured below).
